This agreement is made and entered by and between _____

WHEREAS, the Parties desire to advance CHILD DEVELOPMENT education and aid in meeting the ever increasing demand in the CHILD DEVELOPMENT industry

WHEREAS, it is deemed advised and to the best interest of the parties to establish an affiliation for the purpose of carrying out these objectives.

NOW THEREFORE, for an in consideration of the foregoing and in further consideration of the mutual benefits, the Parties hereto agree as follows:

**ARTICLE I
ORIGINAL TERM, RENEWAL, AND TERMINATION**

**ARTICLE II
RESPONSIBILITIES OF THE PARTIES**

When a public child care/educational center is to be used, the following are required standards related to student participation in the center:

- The course instructor will cooperate with the Center Staff to ensure program standards and competencies of the course are met.
- Conference times will be arranged to allow the center director and the instructor to coordinate classroom and laboratory experiences and to evaluate student performance
- The students will be allowed to progress at their own rate of development, understanding, and skill. The student may not substitute for center staff.
- The center staff will schedule the SWTJC students for the laboratory.
- The number of student trainees will be determined by the enrollment and the program requirements as well as the center needs.

**ARTICLE III
SEVERABILITY**

If any term or provision of this agreement is held to be invalid for any reason, the invalidity of that section shall not affect the validity of any other section of this agreement provided that any invalid provision is not material to the overall purpose and operations of this agreement. The remaining provisions of this agreement shall continue in full force and effect and shall in no way be affected, impaired, or invalidated.

**ARTICLE IV
AMENDMENT**

This agreement may be amended in writing to include any provisions that are agreed to by the contracting parties.

**ARTICLE V
VENUE**

This agreement shall be governed by and construed and enforced in accordance with the laws of the STATE of Texas. Venue will be in accordance with the Texas Civil Practice and remedies Code and amendments thereto.

**ARTICLE VI
ASSIGNMENT**

Neither party shall have the right to assign or transfer their rights to any third parties under the agreement without the prior written consent of the other party.

**ARTICLE VII
INDEPENDENT CONTRACTOR STATUS**

Nothing in this agreement is intended nor shall be construed to create an employer/employee relationship between contracting parties. The sole interest and responsibility of the parties is to ensure that the services covered by this agreement shall be performed and rendered in a competent, efficient, and satisfactory manner.

IN WITNESS WHERE OF, the undersigned parties do hereby bind them to the faithful performance of this contract.

**ARTICLE VIII
NON-DISCRIMIATION STATEMENT**

All parties involved with contract will comply with the following statement: "Provide equal opportunities without regard to race, color, religion, national origin, sex, age, disability, or veteran status."
